PLANNING COMMISSION MINUTES WEDNESDAY FEBRUARY 7th, 2024 @ 7:00 PM

Chairman Marbach called the meeting of the Ontwa Township Planning Commission to order at 7:00pm

Pledge of Allegiance: All rose for the pledge of allegiance.

Chairman Marbach welcomed everyone, stating that there was a quorum present.

Agenda: Chairman Marbach asked if there were any changes, corrections or additions to the agenda as presented. Motion to approve – Mike Mroczek and Meryl Christensen seconded. All were in favor, and the motion carried.

Approval of December 12, 2023, Minutes: Chairman Marbach asked for questions or corrections. Committee Reports:

Master Plan Update: Sandi Seanor stated that Williams and Works are in the process of updating the Master Plan. People had the chance to send in comments on how they would like to see changes in the township and village with land use. Several people have sent in ideas for the land use map. There was a complaint about inconsistent coloring of the maps with the township and

village. Andy will be putting together updated maps. Changes will be made to get the same color.

Zoning Ordinance: Sandi Seanor said there will be a Zoning Ordinance review committee meeting set for early March. On the agenda will be Section 3.26-f. Updates must comply with current standards. Some clarifications on zoning and building code issues. The possibility of certain language removed, hopefully making it easier to read and understand. Updates should bring clarity to the Zoning Administrators job.

Public Comment: Jerry Marchetti encouraged the board members to take advantage of the MSU citizens planner zoom session. A board member noted flyers were passed out for this program.

Announcements: Chairman Marbach announced that township clean up days are April 27th. Volunteers are needed.
