Re: Road end locations

The Cass County Road Commission has researched the plats around Eagle Lake, Garver Lake, Cobert Lake, Pleasant Lake and Christiann Lake to determine where road ends occur. We cross checked our files against known abandonments and replats to come up with the following list of locations.

- 1. There are no road ends at Cobert or Pleasant Lakes.
- There is a road end on Christiann Lake in the Christiana Lodge plat at the end of Christiana
- There are road ends on Garver Lake in the Maple Beach plat at the ends of Garver Avenue, Raymond Avenue and Beach Drive. The road end at Fillmore Avenue was vacated on February 2, 1989. The road end at Lake Avenue was vacated on March 1, 1990.
- There are road ends at Garver Lake in the Shady Beach plat. These consist of three alleys off Lakeview Drive; a fourth located between lots 18 and 19 was vacated on May 16, 1991.
- 5. There is a road end on Eagle Lake in the Plat of Brady, identified as 1st Street and commonly known as Brady Road. The following streets at the water were vacated by Circuit Court on October 6, 1928: 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> Streets. 5<sup>th</sup> and 6<sup>th</sup> Streets were not vacated but homes have been built at the ends of these streets cutting off public access.
- 6. There is a road end on Eagle Lake in the Lakeland Place plat at the end of 8th Street.
- 7. There is a road end on Eagle Lake in the Beardsley Cove plat consisting of a court off Hubble Road now known as South Shore Drive.
- 8. There is a road end on Eagle Lake in the Plat of Oak Beach identified as Oak Lane off Hillside Avenue now known as North Shore Drive.
- 9. There are road ends at Eagle Lake in the Lake View Park plat. These consist of four alleys off High Street.

This comprises the list of road ends we are currently aware of in Ontwa Township.

Attached for your use are copies of the plats we reviewed with notes concerning vacations as necessary.
