- A. A listing of Home Occupation Permit Renewals was presented for review. All current Permits are acceptable. Two businesses did not pay in 2015 so assume they no longer operating and were not renewed.

 Presently the application fee is \$150.00 and \$25.00 per year.
- B. ONTWA TRAILS: Presentation by Don: Don distributed several documents which included informal meetings with the community, Road Commission, neighboring community activity, maps, pictures, and costs for application, administration and maintenance, and a Resolution of the Planning Commission Supporting a grant in the amount of \$250,000 for a 4-5 foot biking shoulder along Elkhart Rd. After listening to Don's presentation, Mr. Marbach noted that he felt there were some questions that he had earlier provided to Don and that there still seemed to be inconsistencies in the documents as presented, and questions still remained. Sandra Seanor further noted that the timetable for grant submission will not be discussed for several weeks. Sandra explained her concerns and in detail the necessary documents that are needed in order to proceed. She noted that the approval of the Elkhart Rd Bike project should be considered premature until the Township had time to understand all of the CCRC requirements for grant submission. Seanor also noted that the consultant document was unclear as to whether the estimates provided were for one or both sides of the roadway. Seanor went on to note that based on the consultant documents provided to her by Don, the cost for the Elkhart project appeared to be at least \$360,000 not the 250,000 listed in the Resolution being considered by the PC. . Chris Marbach further noted that his review of the costs put the project closer to \$425,000. Sandra also expressed a concern that utility relocation may add to the costs.-Seanor suggested that a better alternative might be to consider a project connecting the ESC to downtown and beyond.

Discussions continued – Don said he talked to Pat Bellaire, Village Council member, and Tim Kozal, of the Township Police Dept. Survey presented at a local meeting to build bike trails, showed 53 responded. The Township has a population of about 5,000. Robert Thompson, who is a member of the Road Commission, stated that at the next work session "Trails" is scheduled for discussion. All discussions by the Trails Committee should be with the Administrator, Don Lucas.

Don Delong attended the Michigan Citizens Planner Fundamentals of Planning and Zoning Classes Master Planning Meeting at the Court House in Cassopolis. The Course is \$275.00 and hopes other members can attend future meetings. It covers history, ethics, legal foundations of Planning & Zoning, Master Plans, complete streets and resources available.
